The admission offer is conditional upon successful completion of high school and the fulfillment of the requirements specified in our Admissions and Enrollment Policy. Your individual admission conditions are available for view in the online application portal. All admitted students to Constructor University are required to present an official copy of their high school leaving certificate and final transcripts by **December 31st, 2025**. Proof of additional testing may be required. This requirement will also be listed in your offer conditions on the online application portal. Should you be required to present SAT testing for an unconditional offer of admission, you will be required to take a standardized test (SAT or ACT) with an average of 1200 points (SAT) or 25 points (ACT). Failure to fulfill your admission conditions by **December 31st, 2025** may result in the revocation of your admission offer.

To secure your enrollment at Constructor University, please initiate the payment of a €1000 deposit through the application portal no later than **05.03.2025**. You may need to select a Financing Option before making the payment. After this date, the offer of admission will become invalid.

If you decide to accept Constructor University's offer of admission, you may need to obtain a student visa prior to entering Germany. Please note that the process may take up to several months to complete, so you should start your visa application as soon as possible. Enclosed you will find a document in German (Zulassungsbescheid) that may be used for your visa application at the German embassy or consulate.

Zulassungsbescheid

Adilbek Mukhamedzhan, geboren am 01.08.2006, Staatsangehörigkeit(en): Kazachstan hat sich an der Constructor University um einen Studienplatz im Bachelor Programm in Computer Science beworben und ist nach Prüfung der notwendigen Voraussetzungen zum Fall 2025 an der Constructor University zugelassen. Das Studium beginnt am 01. September 2025, jedoch erwarten wir die Studierenden bereits ab dem 25. August 2025 auf dem Campus, um an Orientierungsveranstaltungen teilnehmen zu können. Adilbek Mukhamedzhan beabsichtigt, bei Ihnen ein Visum zum Zwecke des Studiums in Deutschland zu beantragen.

An der Constructor University weisen die Bewerber ihre Eignung zum Studium durch ein umfassendes Auswahlverfahren nach. Neben Zeugnissen der letzten 2 bis 3 Jahre umfasst die Studienplatzbewerbung ein Motivationsschreiben des Bewerbers und ggf. ein Empfehlungsschreiben. Die Zulassung erfolgt nach Prüfung der Hochschulzugangsberechtigung und steht im Einklang mit §33 Absatz 1 bzw. 3b des Bremischen Hochschulgesetzes.

Die Unterrichtssprache an der Constructor University ist Englisch. Die Constructor University hat die Englischsprachkenntnisse überprüft und als ausreichend für ein englischsprachiges Studium an der Constructor University eingestuft. Die Sprachkenntnisse entsprechen einem TOEFL Niveau von 90 Punkten (internet-basiert) oder besser. Die Überprüfung erfolgt durch die Wertung der Unterrichtssprache in der Schule oder durch international anerkannte Englischsprachtests, wie z.B. TOEFL, IELTS, Duolingo. Ein Nachweis von Deutschkenntnissen ist nicht notwendig.

Die zugelassenen Studierenden müssen zur Immatrikulation ihr Schulabschlusszeugnis und gegebenenfalls SAT oder ACT Ergebnisse vorlegen. Hierbei handelt es sich um standardisierte, international vergleichbare Prüfungen, welche die mathematischen, sprachlichen und logischen Fähigkeiten der Studienplatzbewerber testen. Wir bitten Sie den Visumantrag auch ohne das endgültige Schulabschlusszeugnis auf den Weg zu bringen, so dass ein rechtzeitiges Erscheinen in Bremen gewährleistet ist. Die Vorlage des endgültigen Schulabschlusszeugnisses und der standardisierten Prüfung ist eine Immatrikulationsvoraussetzung und keine Zulassungsvoraussetzung.

Pay the enrollment deposit not later than 05.03.2025

Your enrollment deposit secures your place at the university. Once paid, you'll receive your enrollment confirmation (important for your visa application) and study contract. To make the payment, simply log in to the application portal and click on your application.

Sign the student contract

Once you pay the enrollment deposit, you will receive the study contract, which outlines both your and our obligations. You will need to sign it within 14 days of receiving the document. The signed contract is required before we can send your invoices.

Pay the invoices

You'll receive the invoice(s) based on your selected Financing Option. The payment deadline will be stated on the invoice. Please note: we can only issue the Proof of Funding letter for your visa or confirm your room type choice once the invoices are paid..

Submit the enrollment form

Via the enrollment form, we'll ask for your portrait photo (for your Bremen travel pass and campus card), emergency contact, and some basic statistical details. The form will be sent to you shortly after you sign the study contract and can be completed online.
